#### **TERMS AND CONDITIONS**

- 1. Envelopes containing separate technical and financial bid placed in one envelop properly sealed and stamped should reach to the Office of Director General on October 20, 2022 at 11.30 a.m.
- 2. Bid containing all relevant documents needs to be properly stapled and bind. Documents in loose form / shape will lead to disqualification.
- 3. No secured advance or advance payment whatsoever shall be payable to the supplier.
- 4. Contracting firms must be tax registered with FBR in withholding tax as well as Sales tax and visible on Active Tax payer list. All applicable taxes will be deducted as per Government rules. Suppliers must invariably mention that the rates are inclusive of taxes.
- 5. Sealed bids must be accompanied by bid security for an amount not less than 2% (two percent) of the total tender value) (refundable) in the form of Call deposit Receipt (CDR) / Bank Draft issued by any schedule Bank of Pakistan in the name of Director General, Sports & Youth Affairs, Government of Khyber Pakhtunkhwa to be valid for 180 days (one hundred eighty days).
- 6. Financial bid must be provided on firms' letter head duly signed by authorized person.
- 7. Tenders will be received manually and will be dropped in tender box till 11:30 a.m. on October 20, 2022. The bids will be opened on the same days at 12:00 p.m. in the presence of the bidder or their authorized representative who wish to be present.
- 8. The bidder shall furnish an affidavit on Stamp paper to the effect that the firm is not black listed in any Government Department and no suit with any purchaser is pending in any court of law.
- 9. Conditional, incomplete, unsigned and bid filled with led pencil will not be accepted.
- 10. The purchase committee reserves the right to cancel one or all bids with cogent reason.
- 11. All supplies as per BoQ will be made to the Directorate General of Sports.
- 12. Samples of all items except AC and Table for dinning table must be available with the bid. Bid without samples will be rejected. No item will be awarded on the basis of picture or broachers.
- 13. Work completion certificates must be attached with the bid.

#### Introduction

Details about these items are enclosed herewith at Annex-1.

### Qualification of the Vendor

The following vendors are eligible to apply for the tender:

- 1. Only registered Firm/Supplier can participate in the tender
- 2. The Firm/Supplier registered with FBR (both Income tax and Sales Tax and available on Active tax payer list)
- 3. The Firm/Supplier that have never been black listed by any Government agency or authority.

### **Documents Required**

The firms eligible to apply are required to submit the following documents with their bidding proposal:

- 1. Valid registration documents with Taxation Authorities. NTN/STRN etc.
- 2. In case party fails to provide professional tax certificate the due amount would be deducted from the bill of vendor.
- 3. Audit Report for 3 years i.e 2019 2020 & 2021
- 4. Bank Statement for the last 3 years i.e 2019, 2020- & 2021
- 5. Tax Return for the 3 years i.e 2019,2020 and 2021
- 6. Affidavit, on judicial stamp paper & duly attested by the Oath Commissioner, to the effect that the:
  - a) Firm/Vender has neither been blacklisted by any agency nor is involved in any subversive activities.
  - b) Firm/Vender is/was not involved in any litigation/arbitration and that no work as rescinded in the past.
- 7. Full Address and contact numbers of the office(s).



#### Method of Procurement:

Bidding will be conducted through "Open Competitive Bidding" process, specified in Rules of the Khyber Pakhtunkhwa Public Procurement Goods, Works and Services Rules. Bidding is open to all eligible bidders as defined in the KPRA Procurement Rules 2014 that meet the minimum qualification criteria and required documents. It will be a "Single Stage – Two Envelop" procedure.

#### Response Time:

The sealed bids duly marked as "Bid/Proposal for Procurement of Furnitures for Swabi and DI Khan Sports Complex etc." must reach the office of the Directorate General of Sports Qayyum Stadium Peshawar on or before 11:30 P.M on October 20, 2022.

#### Opening of bids:

Bids received shall be opened on October 20, 2022 at 12:00 P.M. in the committee room of the DIRECTORATE GENERAL OF SPORTS.

All bids shall be opened publicly in the presence of the interested bidders or their authorized representatives who wish to be present.

#### **Bid Price**

Bid prices quoted should be inclusive of all taxes and stamp duties.

The prices quoted shall be binding on the tender for a period 180 days.

The quantity of items to be purchased can be increased / decreased at the quoted / approved rates as per KPPRA rules.

#### **Evaluation of bids:**

All bids should comply with the eligibility criteria and other terms and conditions mentioned herein above.

#### Rejection of bids:

Tax registration documents like NTN, GST, Active tax payer list, bank statement, audit report and tax return are not attached All bids submitted after the time prescribed shall be rejected and returned.

Failure in submission of the above required documents will result the rejection of bid/proposal.

Any bid received without bid security, shall be rejected.

Technical Bid in loose form and not properly bind will lead to rejection of bid.

Samples / Broachers must be provided along with the bid except AC and table for dining table.

Only one price is acceptable for one item. In case of two prices or two samples for one item the bid is liable for rejection.

#### Award of Tender:

Tender would be awarded on the basis of best evaluated bid recommended by the Purchase / Technical committees and approved by competent authority.

#### Other Terms & Conditions

- Copy of valid Professional Tax Certificate. To be provided at the time of award of contract.
- Payment would be made upon completion of delivery of the items.
- All due taxes would be deducted from payments, as per applicable Govt. rules.
- Stamp duty @ 1% of the value of bid would be deducted from the vendor.

#### **EVALUATION CRITERIA**

Detailed technical evaluation for firms will be done who qualify the basic eligibility criteria.

	Marks
Technical Evaluation	70%
Financial Evaluation	30%

Financial bids of firms who score at least 70 % on the technical evaluation (as a whole) will be opened before the representatives who wish to attend the tender opening. 30 % weight age will be given to financial proposals of responding firms. The formula for financial scoring is that the lowest bidder gets 30 points and the other bidders score 30 multiplied by the ratio of the lowest bid divided by the quoted price.

#### Example:

Value quoted by lowest bidder = A

Value quoted by second lowest bidder = B

Value quoted by third lowest bidder = C

Financial scoring of the lowest bidder will be = 30

Financial scoring of the second lowest bidder will be= (A/B)\*30

Financial scoring of the third lowest bidder will be = (A/C)\*30

Technical scoring out of 100 = A

Carried Forward & Prorated Technical scoring = A x 0.7

Points obtained in the detailed technical evaluation will be carried forward & prorated. Tender will be awarded to the Responding Organization with maximum accumulative points (**Technical Score + Financial Score**).

The decision of this Committee will be binding on all concerned and will in no case be challengeable in any forum.
