

### **Framework Contract for the Procurement of Sports Gears / Equipment**

The Directorate General of Sports, Government of Khyber Pakhtunkhwa invites technical and financial bid through the E-Pak Acquisition and Disposal System (EPADS) under National Competitive Bidding from eligible local/national Import/Export, Manufacturing, or Distribution of Sports Goods with at least three (03) years of relevant experience, for the procurement of sports gears and equipment under framework contract as per KPPRA Rules, 2014.

#### **TERMS AND CONDITIONS**

1. Bidders must be registered with the Federal Board of Revenue (FBR), hold valid NTN and Sales Tax (GST) registrations, and be listed on the Active Taxpayers List (ATL).
2. The procurement shall be carried out through the Single Stage – Two Envelope procedure, as prescribed under Rule 6 (2) (b).
3. The bidder must clearly mention their postal address, valid email address, and active contact numbers.
