

# MINUTES OF PRE-BID MEETING

# "Procurement & Installation of Gym / Fitness and Other Equipment"

In pursuance to the advertisement published in the different newspapers, KP-PPRA and Federal PPRA websites, the subject meeting was held in conference room of the Directorate General of Sports, Khyber Pakhtunkhwa Sports Complex - Qayyum Stadium Peshawar on Friday, September 23, 2022 at 11:00 AM in presence of the Procurement Committee for Goods. Attendance sheet annexed.

The following firms participated in the pre-bid meeting.

After recitation of the Holy Quran and introduction, Chairperson Procurement Committee Mrs. Rashida Ghaznavi welcomed all the participants and informed that the purpose of this meeting is to discuss the draft bid solicitation documents including specifications and evaluation criteria and to incorporate the suggestions / comments from prospective bidders, so that the draft may be approved by the competent authority once supplemented/amended.

Mr. Amjad Iqbal Assistant Director (Accounts) added that the draft document for the subject equipment has been prepared keeping in view the requirements & allocated budget of sports department, however your comments / suggestions towards improvement will be appreciated and incorporated if agreed by the committee. Technical Member Mr. Sheraz Coach /Expert Gym Equipment, sports department further added here that once the specifications agreed and the firm could not quote accordingly, shall be declared as non-responsive. Maximum 03 (three) deviations not affecting the performance of the product shall be accepted.

While initiating the discussion Procurement Specialist (Consultant), informed the forum that this document has been prepared in light of KP-PPRA guidelines. The bidding shall be carried out under *Single Stage Two Envelops procedure*. All the

bidders were advised to read these documents thoroughly, however some of the important points were announced as under.

- i. Each firm will submit affidavit as per sample annexed in this document on judicial stamp paper.
- ii. Late bid shall not be entertained / accepted.
- iii. The firm cannot participate in the capacity of Joint Venture
- iv. An affidavit is mandatory in the technical bid that bid security (in original) is placed in the financial bid.
- v. All the relevant documents must be attached with the bid and it is categorically mentioning here that none of the document will be entertained (affecting the bid of the other competitors) once bid submitted and decision will be made on the bid submitted on time prescribed in the advertisement / bid documents.
- vi. Financial bids shall be opened of the technically qualified firms only.
- vii. Each firm shall fill the Bid Cover sheet given in the BSDs.
- viii. Each bidder shall quote its bid including all applicable taxes.
- ix. Each bidder will submit Single bid (in original)
- x. Each bidder shall quote its bid annexure wise along with page numbering.
- *xi.* For specifications each firm shall quote its brand name with proper model / serial number and shall **NOT** use the word "As per specification" or "specifications compliance"
- xii. The successful bidder shall submit the performance security upto 10% of the contract value.
- xiii. The detail of post warranty was explained in detail.

### Eligibility Criteria.

One of the bidder M/s Shoaib Sports Company requested to add the word authorization letter for the quoted equipment along with the authorized dealer in the eligibility criteria. Procurement Committee agreed as this department encourage the open competition, however quality of the equipment cannot be compromised in any case.
